#### 1 Preamble

In order to provide sustainable environmental protection, an efficient and enduring water, wastewater and waste management is of great importance and has become increasingly valuable. The demands and requirements in the field of water, wastewater and waste management have no borders, therefore questions and needs have to be dealt with transnationally.

The framework requirements and demands on countries and national associations, such as CzWA and ÖWAV, steadily converge in the context of a united Europe.

Intention of this agreement is the cooperation and the broad exchange of experience between these two associations concerning technical, scientific, legal and operational issues in the field of water, wastewater and waste management.





## 2 Mutual Memberships

The associations agree upon a mutual membership free of charge:

## 3 Exchange of Expertise

### Technical-Scientific Publications

The associations agree upon a mutual free subscription of all publications:

Therefore publications of the **CzWA** and **ÖWAV** can be requested and are provided for free. Upon request a reviewer's copy of any technical rule or regulation will be forwarded free of charge.

Further, the ÖWAV offers a complimentary standing order of the professional journal "Österreichische Wasser- und Abfallwirtschaft". On the other hand the CzWA provides a free subscription of the publication "Vodní hospodářství".

# Specialists and Experts

**ÖWAV** provides up to three invitations to the annual Austrian Water Management Conference free of charge.

In return **CzWA** invites delegates and experts from Austria to national conferences or other appropriate events to Czech Republic, on a regular basis and free of charge.

# 4 Special Conditions for Delegates

Reduced membership-fees are applicable for delegates of **CzWA** and ÖWAV at other specific conferences of **CzWA** and respectively of ÖWAV in Austria.

#### 5 Joint Ventures

Upon request and if so required CzWA and ÖWAV will jointly organize (international) conferences, courses and workshops.





## 6 International Cooperation

**CzWA** und **ÖWAV** agree upon the best possible mutual support on international level, e.g. through IWA and EWA.

### 7 Period of Validity

The validity of this agreement is for an unlimited period. Both associations can withdraw from this agreement at any time without further reasons.

#### 8 Final Provisions

To animate this agreement, the presidents and responsible executive officers of both associations aim to continuously exchange expertise in order to actively support the association's cooperation.

This **PARTNERSHIP AGREEMENT** replaces the Agreement dated on February 28, 2000, between the former ACE CR Czech Republic and ÖWAV in Austria.
